NEXT GENERAL MEETING

We're Back!!!!!!

Members are invited to attend the next General Meeting to be held on **Thursday 22 October, 2020**, commencing at 8.00 pm, at the Bayside Uniting Church Hall, 420 Wondall Road, Manly West. Due to the ongoing Covid Restrictions, the format will be a little different.

As we are operating under the Uniting Church's Covid Plan, please be aware of some of the Instructions which will be enforced.

- Most importantly, if you are not feeling well, or show any of the flu-like symptoms, please do not attend the meeting. If you do, you may be asked to leave and seek medical attention. Also, if you don't feel comfortable with attending, we accept your decision.
- Entry will be via the usual door, however to Exit the Hall you will need to use the double sliding door (Fire Exit Door). Both doors will be signed appropriately. (This may change on the night due to maintenance around the Hall. There will be plenty of signs to notify members of where they will need to go).

- It will be a condition of entry that members sign the Covid **Attendance Register And Tracing**

Register instead of the regular Attendance Book. **We recommend that you bring your own pen, however, we will have sanitised pens available.**

- Members attending are asked to take their seats as soon as practicable. Unfortunately, due to the current Covid Rules, social distancing does not allow for "small gatherings" at a meeting.
- Hand Sanitising and Cleaning Wipes will be available at designated stations for members' use. Committee members will be sanitising frequently touched areas during the night.
- There will be no Red Spotters or Library available.
- We request that Members bring no more than 4 (four) plants for benching.
- Plants will be displayed out on the side area where the Red Spotters usually operate. Committee members will be monitoring numbers during this time, in order to keep everyone safe.
- There will not be any Judging on the night, however the Popular Vote will still operate.
- Supper will be out in the area between the Hall and the Church. Tea/coffee will be poured by kitchen volunteers who will also add the milk and sugar if required. Individually wrapped biscuits will be provided.

All positions will be declared vacant and nominations / appointments are invited from interested members for the various positions of the society.

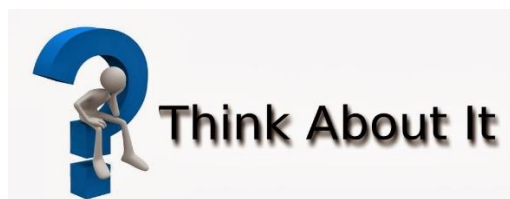
Nominations Forms have been included in this Newsletter and will be also be available from The Secretary at the October General Meeting on Thursday 22 October 2020.
